#### **VULNERABLE POPULATIONS**

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care providers. #### LEAD IN DRINKING WATER

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. #### LEAD EXCEEDANCES IN DRINKING WATER

In August 2019, results from testing for lead in drinking water faucets at 3 out of 20 samples exceeded the EPA action level for total lead in buildings 1721, 1722, and 1730. Non-potable water signs were posted on September 14, 2019. Faucets at Buildings 1721 and 1722 were refurbished and a second set of lead samples were taken on February 15, 2019. Building 1721 had total lead below the EPA lead action level and non-potable signs were removed. Building 1722 had total lead above the EPA lead action level and the non-potable signs are still posted. A combination of likely causes at Building 1722 is older pipe infrastructure and vacant or seldom used facilities. Building 1730 was vacant, and the water was shut off. Building 1730 was secured until it was demolished on Friday, April 17, 2020.

To further evaluate the system, source water and distribution point samples were taken in February 2019. The source water did not exceed the EPA lead action level.

Public Works flushed the water lines in the areas of low water consumption to improve water quality. Forty buildings, including 1721 and 1722, were sampled between December 3 and December 10, 2019. All samples tested had total lead levels below the EPA lead action level. All sampling results have been forwarded to TCEQ per the Lead and Copper Drinking Water Rule.

\*An exceedance of the Lead Action Level is not a violation, but a trigger point requiring additional sampling, monitoring and actions currently being carried out by NASCC PWD.

#### NAS CORPUS CHRISTI DRINKING WATER SOURCE

#### SOURCES OF DRINKING WATER

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPAs Safe Drinking Water Hotline at (800) 426-4791.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

#### Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial
  or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and
  petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Avg:	Regulatory compliance with some Maximum Contaminant Levels (MCLs) are based on running annual average of monthly samples.
Action Level or AL	The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Level 1 Assessment:	A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
Level 2 Assessment:	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
Action Level Goal (ALG):	The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.
Maximum Contaminant Level or MCL:	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
Maximum Contaminant Level Goal or MCLG:	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
Maximum residual disinfectant level or MRDL:	The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
Maximum residual disinfectant level goal or MRDLG:	The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

NOTICE OF VIOLATION: CHLORINE

NASCC failed to submit the required Disinfectant Level Quarterly Operating Report by the due date per 30 TAC Chapter 290.110 (e)(4)(A) and 30 TAC Chapter 290.110(f)(3) for April 1 through June 30, 2019. Only one Certified Public Water System Operator was enrolled in the TCEQ online reporting system and was on extended leave from work when the report was due. The following corrective actions were or are in the process of being completed to resolve the violation:

- 1. The Disinfectant Level Quarterly Operating Report was submitted online on 11 October 2019 by the Certified Public Water System Operator.
- 2. In order to ensure that future reports are submitted on time, an additional Certified Public Water System Operator was enrolled in the TCEQ online reporting system in accordance with 30 TAC 290.46(f)(4)(C) and 30 TAC 19.12(c) to serve as a back-up.
- 3. A Public Notice and Certificate of Delivery is required to inform personnel about the monitoring/reporting violation within one calendar year. NASCC expects the completion of this third corrective action soon.

Total coliform bacteria are used as indicators of microbial contamination of drinking water because testing for them is easy. While not disease-causing organisms themselves, they are often found in association with other microbes that are capable of causing disease. Coliform bacteria are hardier than many disease-causing organisms; therefore, their absence from water is a good indication that the water is microbiologically safe for human consumption.

Disinfection is necessary to ensure that water does not have unacceptable levels of pathogens. Byproducts of disinfection include trihalomethanes (THM) and haloacetic acids (HAA5) which are reported elsewhere in this report. \*Removal ratio is the percent of TOC removed by the treatment process divided by the percent of TOC required by TCEQ to be removed.

Turbidity has no health effects; however, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

Cryptosporidium is of great concern in public water systems that treat surface water for drinking water sources. Resistant to disinfectants, Cryptosporidium can cause gastrointestinal illness in individuals who consume contaminated water. The Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR) is required by Congress in order to increase protection from microbial contaminants such as Cryptosporidium. Under this rule, water systems must conduct monthly Cryptosporidium sampling over a two year span. The City of Corpus Christi completed sampling in July 2019.

Fecal Coliform bacteria, in particular *E. coli*, are members of the coliform bacteria group originating in the intestinal tract of warm-blooded animals and are passed into the environment through feces. The presence of fecal coliform bacteria (*E. coli*) in drinking water may indicate recent contamination of the drinking water with fecal material. Microbes in these wastes can cause short-term effects, such as diarrhea, cramps, nausea, headaches, and other symptoms. They may pose a special health risk for infants, young children, some of the elderly, and people with severely compromised immune systems.

\*\*\*A routine sample and a repeat sample are total coliform positive, and one is also fecal coliform or *E. coli* positive.

#### SECONDARY AND OTHER CONSTITUENTS - NOT ASSOCIATED WITH ADVERSE HEALTH EFFECTS

Many constituents, such as calcium, sodium, or irons, which are often found in drinking water, can cause taste, color and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the USEPA. These constituents are not causes for health concern. Therefore, secondaries are not required to be reported in this document, but they may greatly affect the appearance and taste of your water.
